



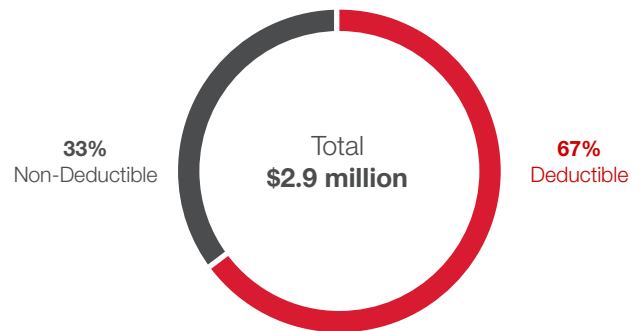
Trade Association and Policy-Based Organization Support
