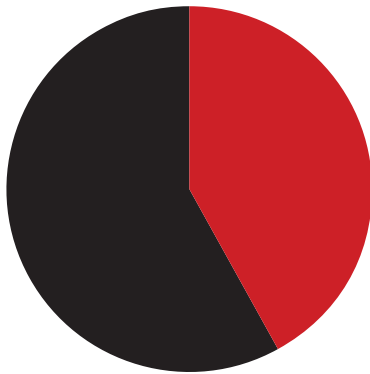




## Trade Association and Policy-Based Organization Support January 1 - December 31, 2010
