Target Corporation Declares Regular Quarterly Dividend

MINNEAPOLIS, March 12 – The board of directors of Target Corporation (NYSE:TGT) has declared a quarterly dividend of 66 cents per common share. The dividend is payable June 10, 2020 to shareholders of record at the close of business May 20, 2020. The 2nd quarter dividend will be the company's 211th consecutive dividend paid since October 1967 when the company became publicly held.
