Target Corporation Declares Regular Quarterly Dividend

MINNEAPOLIS, January 17 – The board of directors of Target Corporation (NYSE:TGT) has declared a quarterly dividend of \$1.10 per common share. The dividend is payable March 10, 2024 to shareholders of record at the close of business February 21, 2024. The 1st quarter dividend will be the company's 226th consecutive dividend paid since October 1967 when the company became publicly held.
